## 2 Important information

Pension Payment Confirmation Statements are not issued every month. Payment Confirmation Statement the month your pension payment begins. You will receive a statement each January or if there is a change to your payment.

To change the amount of income tax being deducted from your pension, complete federal and provincial income tax forms (TD1s). Download the TD1 and TD1P forms from the CRA website. You may also write to SHEPP and request that a specific amount be deducted from your monthly pension payment. Your request should include your name, address, phone number and your signature. We accept forms and/or requests by email or by mail.

- A** **Payment Date** indicates the date your pension payment was deposited to your account.
- B** **Current Month** amounts are for one month only; the current month as of the Payment Date.
- C** **Year To Date** amounts provide a running total to Payment Date for the current calendar year.
- D** **Basic Pension** is the gross basic lifetime pension.
- E** **Bridge Pension** is the bridge benefit payable to age 65. If you are not eligible for a bridge pension this will not appear on your statement.
- F** **Total Gross Pension** is the total payment amount before deductions.
- G** **Income Tax** is deducted according to the federal and provincial tax rates. If you wish to have additional income tax deducted from your pension payment, you can submit your request to SHEPP through a letter or email or by completing a new Federal Tax Form (TD1) and submitting it to SHEPP.
- H** **Group Life** Insurance premium. This benefit is optional and will not appear on your statement if you did not elect to continue coverage. Contact 3sHealth with any and all questions regarding Group Life Insurance.
- I** **Total Deductions** is the total amount of all deductions.
- J** **Net Pension** is equal to Total Gross Pay minus Total Deductions. The Net Pension amount will be deposited to your account on the last banking day of each month (refer to the Pension Payment Schedule for details). If the Net Pension amount changes, you will receive a new Pension Payment Confirmation Statement.
